### **Brokers Check License Status for Agents with DSPS**

Please make sure your agents have renewed their real estate or appraisal licenses for 2025. Also, make sure to check under the relationships tab to verify who is licensed under your firm with the DSPS.

### **REALTOR® Emeritus Status**

A REALTOR® Member who has held membership in the National Association as a REALTOR®, REALTOR-ASSOCIATE®, or both, for a cumulative period of 40 years **and** has completed at least one year of service at the National Association level is eligible for REALTOR® Emeritus status. #### Local Advocacy Initiatives: Current Projects and Future Plans

Local advocacy often requires adaptability and quick pivots, but we're proud to share several impactful projects currently underway or on the horizon:

#### **Green Bay Land Trust**

The housing crisis is a complex issue with no single solution. Years of underproduction, coupled with rising development costs, have contributed to the current shortfall. Communities are exploring innovative strategies and collaborative efforts to address this challenge. One exciting initiative in Green Bay is the development of a Land Trust aimed at creating creating moderate-low income housing and ensuring its long-term affordability. RANW is honored to be part of this taskforce and looks forward to contributing to this transformative effort.

#### Green Bay Zoning Code Update

Zoning codes play a pivotal role in land use and property rights, influencing where, when, and what types of housing are built, as well as the associated costs. Revisiting and refining local zoning regulations is a critical step in tackling the housing crisis. Green Bay has proactively begun reviewing its zoning code, and RANW is privileged to participate in this process. We're committed to ensuring the revised codes support sustainable, affordable housing development.

#### Appleton Comprehensive Plan Update


Comprehensive plans serve as a community's blueprint, offering vital insights into demographic trends, economic conditions, transportation needs, and more. These plans also guide future land use, infrastructure projects, and green space development. Every community is required to update its comprehensive plan every 10 years. RANW is closely involved in Appleton's current update and is proud to contribute to shaping the city's future through this taskforce.

#### **Local Housing Studies**

Several Northeast Wisconsin communities, including Outagamie County, Appleton, Menasha, Oshkosh, Fond du Lac, and Green Bay, have conducted detailed housing studies. These reports provide valuable insights into housing needs and spark meaningful conversations about potential solutions to the current housing shortage. Additional studies, including one for Grand Chute, are expected in 2025. RANW continues to advocate for more communities to undertake these essential studies and remains committed to fostering dialogue and action to address the housing crisis.



## **MLS News**



### **IMPORTANT CHANGES TO MLS RULES:**

### (Rules in effect immediately, fines went into effect January 1, 2025)

CONCESSIONS: In addition to commissions and compensation, RANW MLS will no longer allow any language concerning "concessions" in the MLS. All negotiations that involve seller concessions to buyers are no longer allowed to be displayed in the MLS. This coincides with the rule that was implemented in August 2024 that does not allow any language about any commissions/compensation paid from broker to broker. Violations will incur a \$500 fine, charged to the firm, with the offender being responsible for any legal fees that arise from the violation.

### **LISTING AGREEMENTS & AMENDMENTS**

**DO NOT upload listing agreements and/or amendments into Paragon.** DO NOT email listing agreements and/or amendments to RANW. DO NOT upload ANY documents into Paragon that make ANY reference to concessions, commissions, or compensation of any kind. If RANW requests either of these documents, we will speak to you directly with instructions on sending us the requested documents. Violations will incur a \$500 fine, charged to the firm, with the offender being responsible for any legal fees that arise from the violation. Seller's Authorization for Delayed Showing and Office Exclusive disclosure form must still be uploaded into Paragon.

### Additional Q&A

Q1: Can we still put seller concessions in the remarks if it is for a tangible item like a carpet credit? A1: Yes. But use the word "Allowance" instead of "credit" or saying a "seller concession for carpet". This is acceptable "Seller is offering a \$5000 allowance for carpeting"

Q2: Should we still complete the "Seller Concession Amount" field in the Sold data section after a listing closes?

A2: Yes. That data is still important in making a valuation of the property. Continue to use this field as you do now.

# Text on Photos and Virtually Staged Photos in MLS

RANW MLS now allows text on photos only if it pertains to the subject property (street name, acreage, lot #s, dimensions, body of water name, etc.)

**Virtually staged photos** are approved for additional photo use only. Must have the actual photo as well as staged photo. Use of virtually staged photos must be disclosed in public remarks.


