

NAR Announced the Approval of a Series of Updates to the Multiple Listing Services (MLS) Handbook

RANW MLS has not made any changes to our current rules based on these NAR updates. The MLS Committee will be reviewing the changes from NAR this month.

Below is their summary of the 18 recommended changes in three main categories:

1: Reinforce Local Discretion (7 recommendations)

Policies that allow MLSs more flexibility at the local level.

Examples include clarifying rules around non-member access to MLS and other locally controlled practices.

2: Clarify Administrative and Operational Matters (6 recommendations)

Updates to improve clarity in MLS administration, day-to-day operations, and governance.

Includes adjustments to rules enforcement procedures for better consistency and transparency.

3: Remove Outdated Enforcement Practices (3 recommendations)

Elimination of policies that no longer reflect how MLSs and agents operate today.

Focused on removing obsolete compliance requirements that add unnecessary complexity.

These changes aim to:

- Modernize the MLS Handbook for the first time in 20 years.
- Reduce legal risk for NAR, MLSs, and members.
- Ensure policies align with current industry practices and technology.

Duplicate Listing Fee Raising to \$50 Effective January 1st, 2026

Effective January 1st, the RANW MLS duplicate listing fee will go from \$20 to \$50. Bottom line - if the property is entered into a Paragon a second time, the fee will be \$50 instead of \$20. This could be a condo entered a second time as residential, a commercial entered as residential or other scenario.

After much deliberation, it was the decision of the Board of Directors to raise the duplicate listing fee as the second listing increases the amount of work required.

Changes to MLS Rules

The two following changes were made under the required photos section of MLS rules on page 15:

- Optional Property Floor Plans- may be included as a photo for submitted property, or may be included as an attachment if unbranded.
- Drone Usage: Any photos obtained by the use of a drone must be taken by someone who has complied with FAA regulations for commercial use. LINK TO RULES HERE.
